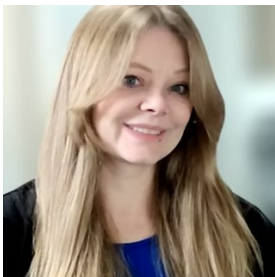
Meet Our New Board of Directors:

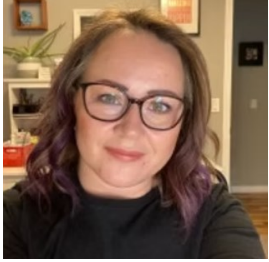
